7A **Ordinance 1071:**: Amending Chapter 96 & Public Hearing

City Manager Mattson stated that the City updated its liquor ordinance in 2017 to allow for new types of licenses that were not covered by the old ordinance. The City accomplished this by adopting a whole new ordinance. At that time it appeared that some language was adopted that made alcohol illegal in all City parks. Prior to this adoption this was not the case. In order to address this issue, it was determined to amend the park ordinance and not the liquor ordinance to allow alcohol in parks.

The proposed language has some restrictions which include: no alcohol on City beaches, within the confines of Maplewood Park unless issued a permit by Council, other than to load or unload a boat onto a lake, and not allowed within Tink Larson Community Field.

Chris Kennedy, Assistant City Attorney, addressed issues that may arise with having alcohol inside Tink Larson Community Field. In addition he suggested some language in the ordinance that will help with enforcement of the ordinance from the Police Department.

Public Hearing opened at 7:45 p.m.

Ann Fitch approached the Council and stated that being able to have a beer at a baseball game on a hot night is nice and that people drink responsibly. She also expressed that Maplewood Park is the least family friendly park, and people should be allowed to have a beer up there. Finally, she stated that you should allow people to have fun in your park system.

James Christiansen informed Council he does not like the term Intoxicating Liquors.

Ann Fitch said that Minnesota is the last State to have 3.2 malt beverages.

Andrew Breck discussed how families these days like to go to the park and meet up with friends and family while having a beer at a picnic or while watching fireworks.

Mr. Mattson made it a point to inform Council that Tink Larson Community Field will be staffed by younger people at the concession stand, and the only City representation on site during events.

James Christiansen recommended sectioning off a location in the stands like the Twins did at Target Field.

City Council discussed and deliberated on whether or not to allow alcohol in Maplewood Park and Tink Larson Community Field.

Public Hearing Closed at 8:21 p.m.

Council Member Tlougan made a motion to amend the proposed Ordinance 1071 to remove Maplewood Park, Tink Larson Community Field, and Beaches from the language. This was seconded by Mayor Srp. Discussion took place with the following final language for Chapter 96.04, paragraph 9 of Ordinance 1071: The display and consumption of intoxicating liquors, 3.2 malt liquors, and malt beverages shall be allowed in City Parks.

Motion was made Tlougan, seconded by Arndt to approve the language as amended.

Motion carried 6-0.

7B Approval of Final Construction Payment: Project 2017-04

Mr. Mattson said the final payments just went through on this project. The sidewalk was done before, but sometimes payments take a while to come through. Council needs to approve the final payment on this project.

Motion was made by Conrath, seconded by Christiansen to approve the final payment. Motion carried 6-0.

7C **Resolution 19-21:** Water Alliance

City Manager Mattson said the City of Waseca along with the County and Woodville Township are looking to join together to take action regarding water issues from Gaiter Lake, Moonen Marsh, Rice Lake, and other places in the Watershed to help improve situations on a regional basis. The other two entities will be approving similar resolutions at their upcoming meetings.

Motion was made by Conrath, seconded by Rose to approve Resolution 19-21. Motion carried 6-0

7D City Council Applicants

Earlier in the evening the City Council held interviews for the vacant Council seat in Ward 1. Mr. John Clemons and Mr. Larry Johnson were interviewed.

Motion was made by Christiansen, seconded by Rose to appoint Larry Johnson to the City Council representing Ward 1. Motion carried 6-0.
