BACKGROUND: A petition for annexation was received on May 15, 2020 for annexation of the subject property. The property is located at the west edge of the City of Waseca, south of Brown Avenue, and adjacent to part of the former Quad Graphics property and consists of 120 acres. The property is currently undeveloped and is being used for agriculture. The Waseca Comprehensive Plan guides this property industrial expansion.

The purpose of the annexation is to allow the property owner to consider future industrial expansion with access to municipal utilities. Upon Annexation it is recommended that the property be zoned I-2, Moderate Industry District. This zoning is consistent with the guidance of the Comprehensive Plan for the City.

BUDGET IMPACT: Tax revenue from the property.

POLICY QUESTION: The City Council has the authority to approve annexations.

ALTERNATIVES CONSIDERED: None.

RECOMMENDATION: Staff is recommending adoption of Ordinance No. 1081.

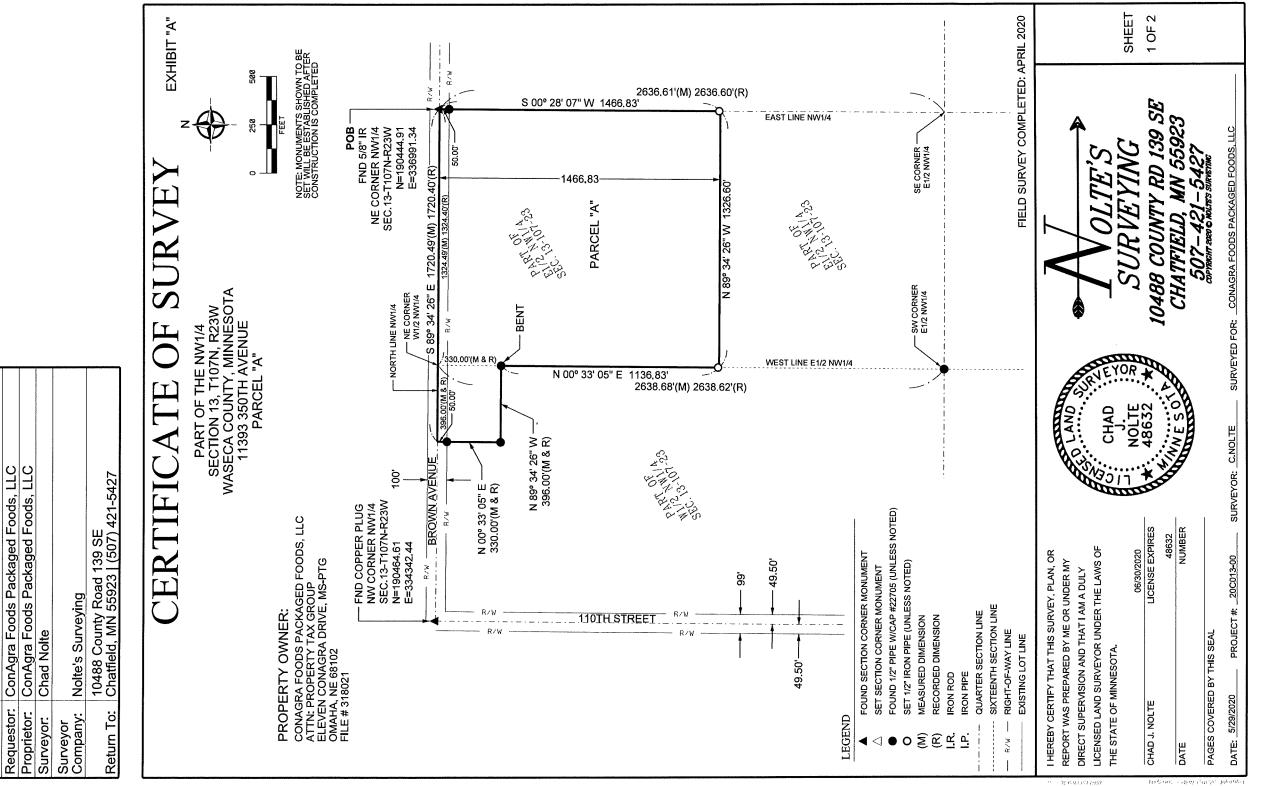

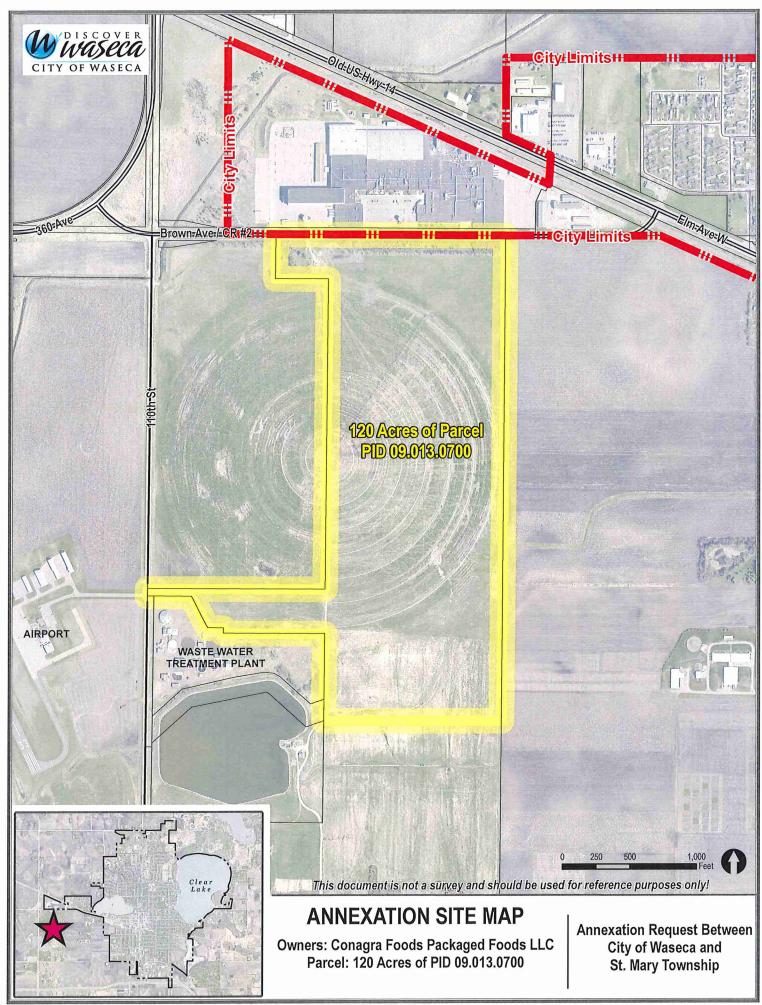
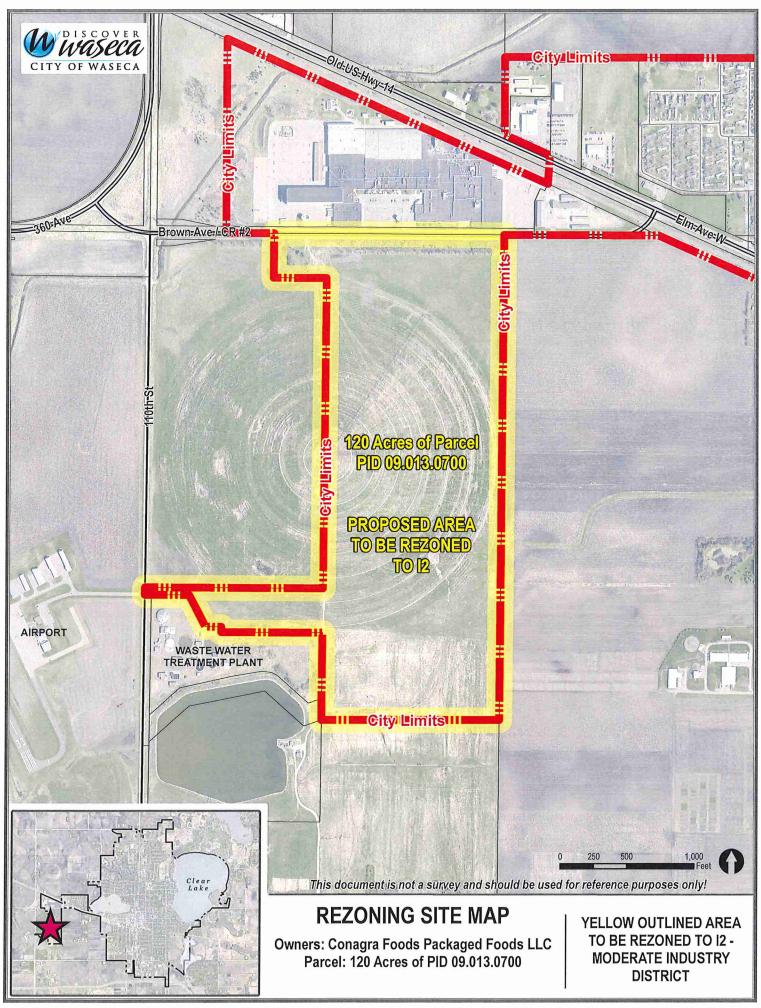

BACKGROUND: In December of 2019, the City Council asked the Airport Board for a recommendation on residency requirements for membership on the Airport Board. Current code provides that three of the five members must reside within the corporate limits of Waseca. The Airport Board has recommended that the City remove all city residency (residency within Waseca County would still be required) requirements for membership on the Board and contact a number of individuals who have expressed interest in serving on the board to begin a process of selecting someone to fill the current city-resident-limited seat that is vacant.

An ordinance was introduced at the February 18, 2020 Council Meeting. A Public Hearing is set for tonight's meeting to hear from residents on whether they like or dislike the change to the current ordinance language.

ALTERNATIVES CONSIDERED: The Council may choose not to adopt Ordinance 1075 and continue allowing for only 2 non-resident members to be part of the Airport Board.

RECOMMENDATION: Staff asks that Council adopt Ordinance 1075 to allow for three non-resident members to be on the Airport Board.

ORDINANCE NO. 1075

AN ORDINANCE AMENDING CHAPTER 37; BOARDS, COMMISSIONS AND AUTHORITIES OF THE WASECA CODE OF ORDINANCES REGARDING NUMBER OF AIRPORT BOARD MEMBERS

WHEREAS, Chapter 37 of the Waseca Code of Ordinances provides for the establishment of the Airport Board; and

WHEREAS, the Airport Board is required to have five members, one of which is a City Council Representative and all of which must be appointed by the City Council to serve a three-year term; and

WHEREAS, it has grown increasingly difficult to attract new resident volunteers to serve on the Airport Board, which is therefore causing difficulty in achieving a full quorum.

NOW, THEREFORE, the City of Waseca does hereby ordain that the amendments to Chapter 37 of the Waseca Code of Ordinances as shown here-in are hereby approved and modified. The modification only amends the specified codes, the remainder of the Ordinance shall remain as previously adopted.

SECTION 1. Chapter 37, Boards, Commissions and Authorities of the Waseca Code of Ordinances is hereby amended as follows, underlined <u>text</u> is being added and strikeout text is being deleted:

§ 37.01 (C) Exception:

The Planning Commission may have one non-resident member who resides outside of the municipal city limits, but resides within the two-mile planning area. The Airport Advisory Board may have up to two three non-resident members who reside outside of the municipal city limits, but reside within the limits of Waseca County.

SECTION 2. This Ordinance shall take and be in force 10 days after it's adopted.

Dear Governor Walz:

The City of Waseca has learned that our non-profit agencies are under severe financial strain and are in danger of having to close their doors. Unfortunately, they have not been eligible to receive any of the State or Federal assistance that has been available to businesses. In reality, these entities can be at least important for local economies as our businesses, but their abilities to generate revenues have been tremendously hampered by COVID19. While largely self-sufficient during normal times, they are virtually cut off from meaningful abilities to sustain operations.

For some of these non-profits, the impacts surge through many more people than fill the staff positions. For example, some of our non-profits that work with local employers to provide contract workers. Serving people who have disabilities of many different types, they have suffered sudden drops in demand for their clients. The fees paid by employers for the contracted services covered the organizational overhead as well as the direct income paid to their clients. In the meantime, they are burning through their meager cash reserves to try and be ready to again serve their business customers. For these organizations, they truly are in a crisis.

If they close, their clients will probably have no other real opportunities to earn income and will ultimately become a burden, or larger burden, on State and local resources. The network that can include them in the working economy will be broken and will be costly in time and money to reconstruct. Their clients will lose the dignity of work and inclusion in significant parts if society.

The City of Waseca realizes the demand for help from the State. Our Economic Development Authority has dispersed \$225,000 to augment the State and Federal business programs and help many businesses including many that did not qualify for other assistance programs. This has depleted our ability to extend further aid at this time. However, we do recognize the need for help our non-profits are suffering. This is not just a Waseca problem, but one that Is statewide.

We ask that the Office of Governor join forces with legislative leaders to find a way to help these vital non-profit organizations survive as the valuable resources they are.

BACKGROUND: In November 2019, Stantec Architecture Inc. completed a facility assessment on the Tink Larson Community Field (TLCF) dugouts. It was determined the dugouts were structurally sound and could be renovated as opposed to re-building. In January 2020, City staff accepted a proposal from Stantec Architecture Inc. to develop plans and specifications related to renovating the Tink Larson Community Field Dugouts.

A pre-bid contractor meeting was held on June 9, 2020 at TLCF and bid opening was on June 23, 2020. In general, work consists of improvements to both dugouts including cleaning and re-painting the concrete block, facing the exterior of both dugouts with thin brick veneer, replacement of prefinished metal fascia at both dugouts, and installation of a new 5'-0" high chain link fence with padding at top rail and end posts at both dugouts. A new 5'-0" high chain link fence in front of both dugouts will enhance player and coach safety in the case of foul balls or an errant throw entering the dugouts.

BUDGET IMPACT: Utilize remaining donations and funds from TLCF fundraising options: \$58,454. Any overages will be accounted for in the Capital Improvement Fund (430) and offset with future TLCF donations.

- Stantec's design and bidding services is not to exceed \$8,400 (plus reimbursables).
- Stantec's Construction phase is not to exceed at \$8,400 + up to \$1,500 reimbursables.
- Fendler Patterson Dugout Improvements total base bid amount of \$55,000
